CONTRACTOR REGISTRATION

Builders/Contractors who must register with the State "Texas Residential Construction Commission" must provide proof of registration.

Contractors must provide proof of insurance. The State may require specific insurance and it must be provided to the City. You must provide proof of General Liability Insurance showing the City of Cibolo as a Certificate Holder. The minimum amount of insurance required is \$1,000,000; or a minimum of \$300,000 if you are a Limited Contractor. **ALL PROOF OF INSURANCE MUST BE AN ORIGINAL.**

In addition, all contractors (with the exception of plumbers, who are bonded by the State) must provide a License/Permit in the amount of \$5,000 to the City of Cibolo.
THE BOND MUST BE AN ORIGINAL.

All work is to be performed in accordance with the International codes adopted by the City, National Electric Code, the laws of the State of Texas, and other ordinances adopted by the City of Cibolo.

All registrations expire on December 31st of each year. Registration fee is \$65.00. No exceptions. (Registration: City ordinance 751, dated June 27, 2006)
